The Kenyan shilling: held steady yesterday against the US currency amidst a lacklustre session.

Equity Market: The NSE-20 lost points 7 to close at 1874 yesterday.

Fixed income: In the debt market, bonds worth Kes0.532 Billion were traded yesterday.

GLOBAL MARKETS UDPATE

EUR: The pair spent the Asian session fluctuating in a relatively tight range but came under strong bearish pressure in the early trading hours of the European session.

GBP: The pair rose against all its Group-of-10 peers on expectations the U.K. will confirm all residents at eligible care homes have been offered a corona virus vaccine.

INR: The Indian Rupee gained as emerging-market stocks headed for the biggest gain in three weeks as global equities rallied, as last week's volatility moderated and risk-off sentiment picked up.

GOLD: The commodity market gained yesterday, on increased optimism about economic stimulus and global recovery.

CRUDE: The commodity prices settled higher yesterday buoyed by falling U.S. crude inventories.

UGX: The Uganda Shilling remained in the established range against the US Dollar for the second consecutive session yesterday.
